We need people who are transparent

Sir, As a parent and having previously taught in schools that supported significant numbers of families in need, I've become very interested in the debate on appropriate housing provision in the town. I am concerned that those families in housing need will get lost in the political arguments for and against mass development as a whole. UDC have constantly referred to the number of 1,600 on the housing waiting lists in Uttlesford as a reason to green light more housing as a whole, when the truth is that there are half the number.

The actual figure on the list is 754 families in band A-D, i.e. those who are not adequately housed, and of those, 638 have an Uttlesford connection. UDC haven't provided the details of those specific settlements that are most in need, which is surely essential to make sure that we build the right houses in the right

places!
This all proves both the frailty and the futility of the Local Plan – affordable housing that supports our local families that are most in need, must be strategically targeted to the areas that specifically require it. Furthermore, I am disappointed that UDC have appeared to mislead residents with incorrect numbers and worse still, appear to be using housing need as a tool for political leverage in order to justify generic mass development. Now is the time to make sure that as a community, we have representatives that are transparent with all the information, that support the actual housing needs of local families and have the strength to demand the best deal possible from developers and landowners.
